Dear Praying Friends,

The situation with Bob's mom has progressed forward, but is still not completed. The end is in sight, and hopefully the process will be terminated soon. Please keep praying for the final decree needed by the judge. Bob will be staying in Romania until the final ruling is handed down, and once that happens we will know how to proceed. We will update you further when we know more.

Marianne has been experiencing some problems over the past few years with constipation, nausea and abdominal pain. Surgery was recommended last year, but the insurance company would not authorize payment. But, she continued to feel worse, especially over the last year. We finally got approval for the surgery which would be a laparoscopic procedure to remove adhesions from prior surgeries that were believed to be attached to her bowel. During the pretesting for the surgery, it was discovered that she had a hiatal hernia, which also needed to be repaired. The surgery was on Sept. 25th, and it was successful. The hiatal hernia was repaired and the adhesions were removed. It was very fortunate that she had the surgery because there were portions of the bowel where the bowel was folded on itself due to the adhesions. The potential for blockages was quite possible in the near future. She is doing well and is recuperating at home.

Costel appears to be recovering well. He has a 3 month post op visit later this month which will reveal the full extent of his recovery.

The man who wants to purchase our current church building has still not made a firm commitment. Please pray that the man will commit to buy and give us a firm date.

Please continue to pray for Bogdan's salvation. He continues to attend faithfully.
